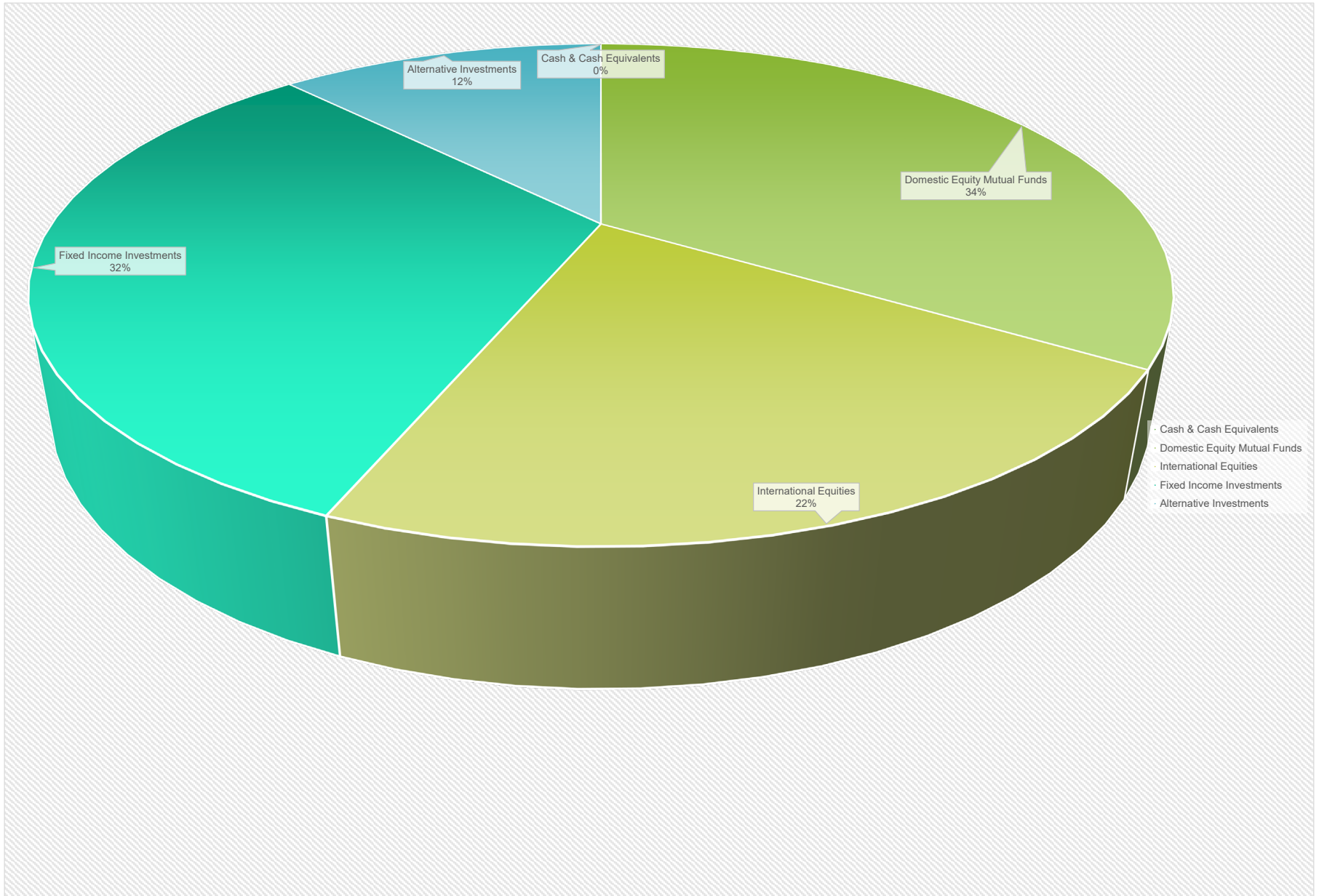

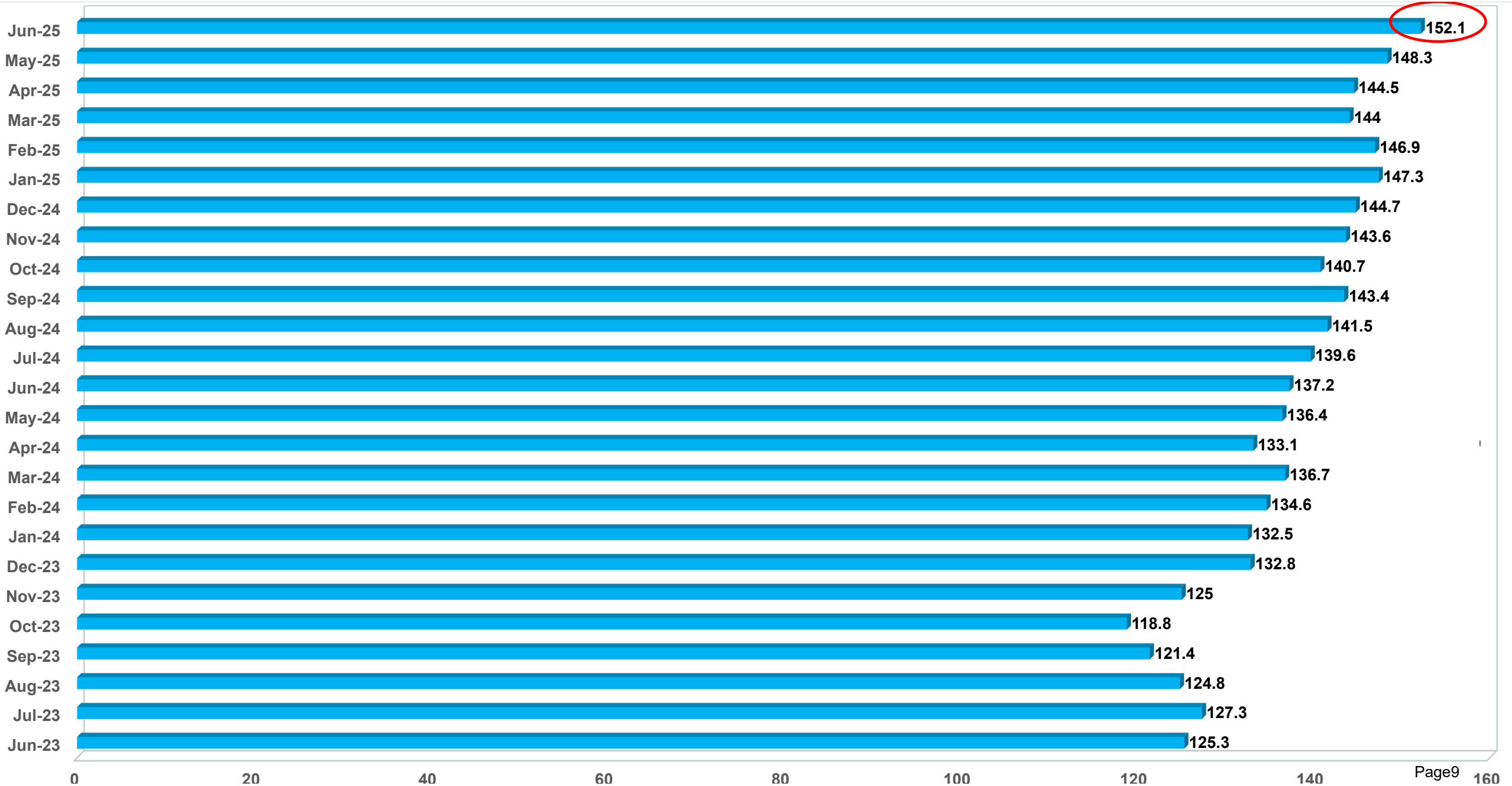

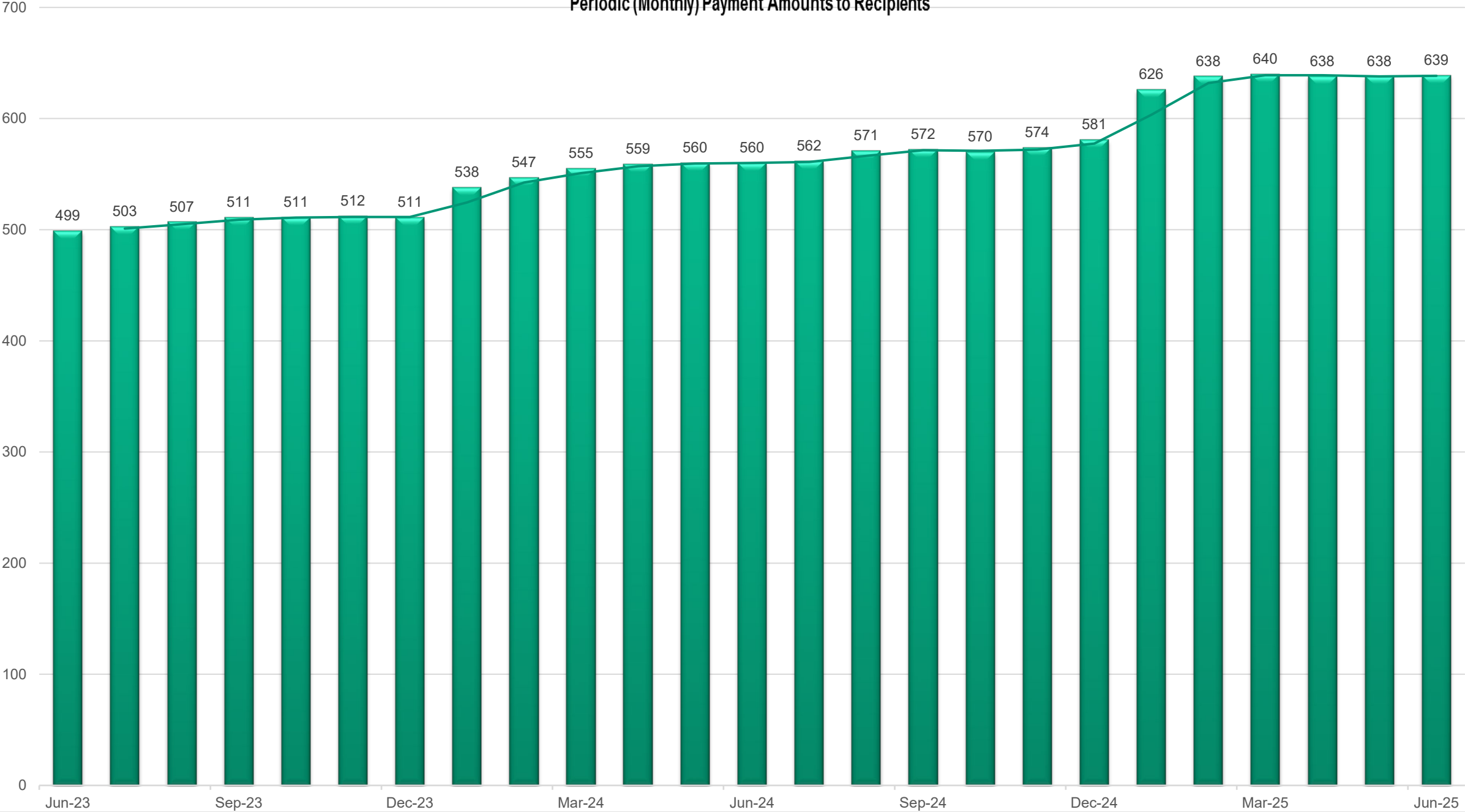


# Pension Market Value in Millions
