Drug and Alcohol Assessment (DDAP)

A drug and Alcohol Assessment may be REQUIRED IF:

- a. BAC was .16 or greater
- b. Refused the chemical testing
- c. Drug related DUI (including Marijuana)
- d. Under 21 years old at time of offense
- e. Prior DUI
- f. If CRN results recommend an assessment
