According to the CDC, **elder abuse** is "an intentional act or failure to act that causes or creates a risk of harm to an older adult". Abuse can come in different forms:

- Physical Abuse: physical force resulting in injury, pain, or impairment to a vulnerable older adult
- Emotional Abuse: infliction of pain or distress via verbal or nonverbal means
- Sexual Abuse: nonconsensual sexual contact of any kind with a vulnerable older adult
- Financial Exploitation: illegal/improper use of a vulnerable older adult's property, funds, or assets
- Neglect: refusal or failure of those responsible to provide life necessities for a vulnerable older adult
- Abandonment: desertion of a vulnerable older adult by the person who took responsibility for them

# **OPTIONS (HELP AT HOME)**

#### Monroe County Area Agency on Aging — (570) 420-3735

Help at Home, more commonly referred to as the OPTIONS program, assists PA residents ages 60+ who would like to stay in their home. The program offers:

- Care Management: ongoing care plan management to ensure needs are being met
- In-Home Meals: delivered, in-home meals
- Personal Care Services: assistance with daily living activities
- Home Support: basic housekeeping, shopping, and laundry
- Personal Emergency Response System: an electronic device for high-risk consumers in case of an emergency

The **Long-Term Care Ombudsman Program** offers free and confidential services to **residents living in a long-term care facility**. An ombudsman can help with resident rights, quality of care, medications, privacy needs, etc.

#### CAREGIVER SUPPORT PROGRAM

The Pennsylvania Caregiver Support Program provides resources and assistance to individuals who assume the primary responsibility for the provision of care to encourage a healthy, ongoing relationship with their care receiver. The program aims to alleviate the stresses associated with caregiving by focusing on the wellbeing of the caregiver, providing access to respite care, addressing the need for formal and informal supports, and providing financial reimbursement for out-of-pocket costs associated with caregiving-related services and supplies. Qualified caregivers must be at least 55 years of age and care for either a related child or a related disabled adult. A caregiver can also be an adult of any age who is caring for a senior or somebody with Alzheimer's or a related disorder. The program is administered by the Monroe County Area Agency on Aging. Each caregiver is assigned a care manager who will come to the care receiver's home, conduct a comprehensive assessment of the needs of the caregiver, provide support, and work with them to develop a person-centered plan of care.

### **MEDICARE**

**Medicare** is a federal health insurance program which generally provides coverage to individuals who are 65 or older, younger people with disabilities, and people with endstage renal disease. Medicare is comprised of different parts to cover specific services:

- •Part A covers inpatient hospital stays, care in a skilled nursing facility, hospice care, and some home healthcare.
- •Part B covers certain doctors' services, outpatient care, medical supplies, and preventative services. The premium for 2024 is \$174.70/month.
- •Part C (AKA Medicare Advantage Plans) is an all-in-one alternative to Original Medicare. These packages include Parts A, B, and usually D.
- •Part D adds prescription drug coverage.

Medicare does not pay all costs; supplemental insurance plans, commonly called Medigap, can be purchased through private insurance companies.

Eligible persons may be able to receive help to pay their Medicare premiums through a coverage plan under Medicaid called **Healthy Horizons**. Individuals must meet income and resource limits. Income limits are based on a percentage of the Federal Poverty Income Guidelines (FPIG), which are revised annually. #### **AFFORDABLE CARE ACT**

The Affordable Care Act (ACA) is a comprehensive healthcare reform law enacted in March 2010. Its goal is to make affordable health insurance available to more people by providing subsidies that lower costs for households that meet certain income guidelines. The marketplace is not for people who already have health coverage such as Medicare, Medicaid, TRICARE, or VA coverage, nor is it for people with employer coverage, except when the employer plan is considered "unaffordable" or "inadequate". Pennsylvania's health coverage marketplace is called Pennie.

#### **PA MEDI**

Pennsylvania Medicare Education and Decision Insight, also known as PA MEDI (formerly APPRISE), offers free Medicare counseling to older Pennsylvanians. PA MEDI counselors are specially trained to answer questions and provide free, unbiased, personalized help with detailed information about Medicare, Medicare supplemental insurance, Medicare Advantage Plans, prescription drug plans, enrollment assistance, Medicare rules/notices/billing, financial assistance programs, appeals, long-term care assistance, and coordination of benefits. PA MEDI counselors do not sell Medicare products but rather offer current, unbiased Medicare education to help those interested make the most informed choice about the Medicare options available. Medicare Open Enrollment takes place October 15th to December 7th each year. During this time, Medicare beneficiaries can make changes to their Medicare health and prescription coverage for the following year. Coverage, costs, and medication formularies change annually and, in most cases, the Open Enrollment Period is the only time to make changes to health and prescription coverage. # **MEDICAID**

Medical Assistance (MA), also known as Medicaid, pays for healthcare services for eligible individuals. Eligibility is determined by evaluating income and assets. The income guidelines vary depending on specific Medicaid programs. The Monroe County Assistance Office is located at 1972 West Main Street, Suite 101, Stroudsburg, PA 18360.

The **Pharmaceutical Assistance Contract for the Elderly (PACE)** program offers eligible seniors low-cost prescription medications. To qualify, individuals must be 65 years of age or older, a Pennsylvania resident for at least 60 days, and meet these income requirements:

<sup>\*</sup>Certain income sources and Medicare Part B premiums are not counted as income for PACE/PACENET purposes.

Eligible applicants will receive an identification card that can be presented at the pharmacy (along with their Medicare Part D plan card if they are enrolled in that too). PACE cardholders not enrolled in a Medicare Part D plan will pay a monthly deductible of \$41.08 at the pharmacy.

# **MEDICINE ASSISTANCE TOOL**

Pharmaceutical Research and Manufacturers of America's (PhRMA) **Medicine Assistance Tool (MAT)** is a web platform designed to help patients, caregivers, and healthcare providers learn more about the resources available through the various biopharmaceutical industry programs. These programs are offered to those who need financial support due to their lack of insurance or inadequate prescription medicine coverage. MAT is not its own patient assistance program; rather, it is a search engine for many of the support programs and resources that the biopharmaceutical industry offers.

#### **DONATED DENTAL SERVICES**

Donated Dental Services (DDS) volunteers provide comprehensive dental treatment to eligible patients who are elderly or permanently disabled. Major dental treatment services include oral surgery, periodontics, orthodontics, endodontics, and prosthodontics. Volunteers do not provide emergency services. Applicants must have no means to afford dental care and must be either over 65 or permanently disabled. Due to lengthy waitlists in Monroe County, it is suggested that aspiring candidates call before completing an application. Exceptions are sometimes made when there is documentation from a physician stating essential medical treatment cannot be given due to the dental condition. Veterans can apply even when the program is closed.

### **CHRONIC RENAL DISEASE PROGRAM**

The Chronic Renal Disease Program (CRDP) provides lifesaving care and treatment for adults with end-stage renal disease. To be eligible, patients must be a US citizen, a Pennsylvania resident, have an end-stage renal disease diagnosis, and have an income at or below 325 percent of the federal poverty income guidelines. The CRDP is the payor of last resort; eligible patients enroll in the program through the PA Department of Health to supplement their existing insurance benefits. Patients receive an ID card to present at participating dialysis facilities, hospitals, and physician offices

when getting treatment. Patients can also receive prescription drug benefits to offset the cost of their renal disease medications and transportation services to get to treatment.

To enroll, patients must provide proof of residency, income.

To enroll, patients must provide proof of residency, income information, and a physician statement verifying medical qualifications. Enrollment applications are available at Medicare-approved dialysis facilities, online at the website above, and at the Monroe County Area Agency on Aging.

Sights for Hope is a United Way agency serving Monroe County's visually impaired and blind individuals by providing free social services that promote independence, such as escorted transportation for essential needs and assistance with chores like writing checks, reading correspondence, and labeling and organizing household items.

The agency also offers support group sessions and life skills classes that provide discussions on issues related to vision loss, adaptive ways of handling household tasks, and navigating inside and outside the home. They also operate a low-vision outlet store which is open to the public and sells helpful products such as talking watches and clocks, large-numbered phones, and magnifiers at a reduced price. Limited free vision screenings are available along with educational programs on eye safety, eye diseases, and blindness prevention. They are located at 4215 Manor Drive, Stroudsburg, PA 18360.

Older patients suffering from chronic conditions like arthritis or back issues are often prescribed opioids to relieve pain. These individuals can become more at risk for drug dependence and overdose. Symptoms of Substance Use Disorder, such as increasing fatigue, diminishing memory, or balance problems, can be mistaken for depression or dementia. Also, since kidney and liver function slow with age, the time drugs remain in one's system increases, making it harder to manage opioid medication effectively.



Income eligibility for the program is figured differently for those 60+.

Monroe County Meals on Wheels is a local nonprofit organization whose mission is to help ensure older adults and the homebound in our community receive nutritious meals. Participants can choose between two programs: weekly freezer packs or daily hot meals. Volunteers and staff also offer emotional support through wellness checks and phone calls.

Products are provided by the USDA and include bottles of 100% juice, cheese, canned fruits and vegetables, canned meats and stews, milk, cereal, peanut butter, and more. Senior boxes are distributed locally through the Salvation Army in East Stroudsburg. Registration is required at least two weeks prior to distribution.

The **Section 504 Home Repair program** provides loans to very-low-income homeowners to repair, improve, or modernize their homes or grants to elderly very-low-income homeowners to remove health and safety hazards. **To qualify, applicants must own and occupy the home, be unable to obtain affordable credit elsewhere, have a household income that does not exceed the very low limit by county, and (for grants) be 62 or older. The maximum loan is \$40,000, and the maximum grant is \$10,000.**

Homeowners, renters, and some residents of personal care/nursing homes may be eligible for a **rebate on their paid taxes or rent**. Applicants must be 65 or older, widows/ widowers 50 or older, or 18 or older with a disability. Starting January 16th, the Dept. of Revenue will open the filing period for those eligible to submit applications for rebates on property taxes and rent paid in 2023. **The maximum standard rebate has increased from \$650 to \$1,000**, and the **income cap for both renters and homeowners has increased to \$45,000/year**.

**April:** Posting/processing begins, and automated calls begin to notify applicants their applications were received.

**June:** Automated calls begin to notify applicants that their applications were approved. Filing deadline is June 30th, but it could be extended.

July: Rebates will start to be paid out on July 1st.

A **federal income tax return for 2023** must be filed if a certain amount of gross income was made. The following apply to those 65 and older:

**Single filing status** must file if total gross income was **\$15,700 or more**.

<u>Joint filing status</u> must file if combined gross income was \$30,700 or more. If spouse is under 65, threshold decreases to \$29,200 or more.

Free assistance in completing federal income tax returns may be available for those ages 60 and older by AARP and United Way volunteers through the income-based Volunteer Income Tax Assistance (VITA) Program. 

Social Security is the nation's basic method of providing a continuing income when family earnings are reduced or end due to retirement, disability, or death. One may begin receiving benefits between 62 and 70 years of age. Exceptions apply to some workers who become severely disabled before turning 65, who may be eligible to receive Social Security Disability benefits. Certain family members can receive survivors benefits if a worker passes away. Monthly benefits had a 3.2% increase in 2024. Applications can be submitted up to 3 months prior to the planned retirement date. The Social Security office is at 9090 Franklin Hill Road, Suite 101, East Stroudsburg, PA 18301.

Supplemental Security Income (SSI) is a federal program that provides monthly income to persons ages 65+ with little to no income or resources and people with disabilities. Eligible persons' monthly payments vary depending on their living situation, income, and assets. Most of these **benefits require a particular period of service and an honorable discharge**; all other types of discharges are subject to review on a case-by-case basis. The **Veterans Pension program** provides monthly payments to wartime Veterans. The pension benefit is income-based, and compensation is determined by disabilities related to service. There's also a **Veterans Discount Card** which may be used at select businesses within Monroe County. **Some other benefits** include a \$100 county death benefit for burial of a veteran or their widow, grave flag holders and flags, \$100 headstone installation, recording and certified copies of DD214s, written correspondence for Veterans and dependents involving Federal or State benefits, and more. The **Monroe County Transit Authority (MCTA)**, aka Pocono Pony, offers a variety of public transportation services to all residents of Monroe County. All vehicles are ADA accessible. Programs that apply to **seniors**, 65 years of age and older, include:

The **Fixed Route** provides free transportation for seniors. Application for a transit card requires proof of age. Seniors can apply in person at MCTA, 134 MCTA Drive, Swiftwater, PA 18370 and the Loder Senior Center, 62 Analomink Street, East Stroudsburg, PA 18301. Applications can be found online at gometa.com or apply.findmyride.penndot.pa.gov

The **Shared Ride Program** provides rides for those who live more than ¼ of a mile from a Fixed Route bus stop, allowing seniors to use public transit to get to medical appointments, grocery stores, and social outings. The program requires an application as well as trip reservations. Trips must be scheduled by noon the day before the requested trip; however, reservations can be made up to two weeks in advance. Shared Ride requires a copay.

The **Medical Assistance Transportation Program** offers free transportation for medical-related trips only via Fixed Route or Shared Ride as well as mileage reimbursement. The program requires an application, and clients must be enrolled in Medical Assistance, aka Medicaid.

### Other transportation options:

**PonyPlus** is an on-demand service open to all ages and runs from 6:30am to 6:30pm Monday through Friday in two geographic areas: Tri-Boro Connector (Delaware Water Gap, East Stroudsburg, and Stroudsburg boroughs) and Pocono Summit Connector (Pocono Summit and Mount Pocono Borough). Using the PonyPlus smartphone app, customers can book a ride for \$2 per trip.

Income from other sources must be considered when calculating total income, which must not exceed \$19,200. The vehicle must be titled/registered to the applicant's name, and if the vehicle is registered jointly, at least one of the registrants must meet the above requirements. A physician or police officer must verify the applicant's disability, and the form needs to be notarized. Veteran placards and plates require
