

# MONROE COUNTY FIELD USAGE REQUEST FORM

Sporting event requests for the Monroe County Athletic Fields & Burley Fields must be submitted to the Monroe County Planning Commission (MCPC) . **Field Usage Requests will be accepted from February - October** and will be reviewed within two weeks of the submission date.

The request & approval process, outlined below, requires the applicant to follow up with payment and insurance documents after MCPC's initial review. Timing for receiving final approval is dependent on the applicants response time to MCPC's invoice requirements. **Reservations are not final until MCPC issues a Field Usage Approval Form.**

## Request & Approval Process

### Step One

Applicant submits a fully executed Monroe County Field Usage Request Form and Covid-19 Mitigation Plan to MCPC.

### Step Two

MCPC reviews request, if dates are available a temporary hold is placed on behalf of the applicant and MCPC issues an invoice with a deadline for securing desired dates.

### Step Three

Applicant submits payment, and certificates of liability to MCPC by deadline listed on the invoice.

### Step Four

If payment and insurance requirements are satisfied by the deadline on the invoice, MCPC finalizes the reservation and sends applicant a Field Usage Approval Form as confirmation of the reservation.
